## IPM statement

It is the goal of the Durham Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to:

Focus on long-term pest control utilizing safe and effective measures.

## Pest management contracting

- Pest management services are contracted to a licensed pest control business.

Pest Control Business

- Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

## Pest identification, monitoring and inspection

- Pest Identification is done by: District maintenance and grounds staff, private pest control company
- Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by District maintenance and grounds staff, private pest control company and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

Sticky monitoring boards are placed in kitchen and monitored daily by custodial and kitchen staff.  
Traps are placed in kitchen areas and some offices and are monitored daily by staff.  
Indicators of possible outdoor pests are monitored weekly by grounds staff.

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt<sup>1</sup> from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)
